Prelude to analysis of Truth-Labs 22 Minute Audio/Video

Proof 1: The Audible Conversation With HDG

We remember HDG as a robust, fast walking septuagenarian who had diabetes—that he knowingly ignored. Kaviraja & BCS asked “Who said?” PPd: 7:05 “All these friends... They all Say.” (Everyone who visits him!)

Kaviraja & TKG ask: 7:30 “Who will give you poison?”

PPd responded incredulously: 7:48 “I do not know (who said it) but it is said...” Realizing they were making a big deal out of this simple observation PPd changed the subject: 8:09 “Do you know astrology?”

Overly concerned 17:45 minutes later the kaviraja asked again 25:15 “someone gave you poison?” & PPd admonishes him: 24:24 “NO! Someone said that, when given poison² this happens... Maybe (my symptoms) it’s written in some book?”

The Kaviraja explains how consuming some foods or raw mercury could be the cause of Srila Prabhupada’s maladies. He elaborates that there are also other things that could have caused his health to decline. He then questions; Who would poison a saint like Srila Prabhupada intentionally? Only a terrible demon could even think of such a thing. Then next day TKG still concerned asks for a third time: 15:38 “you... said that you were poisoned?”³ and PPd responded firmly, clearly and even a bit dismayed...

16:07 “NO! These kind of symptoms are seen when a man is poisoned. ...

He said like that, **not that I am poisoned.**

Tamal Krishna persists: 16:14 “Did anyone tell you that (how your symptoms are same as those when a man is poisoned), or you just know it from before?”

16:21 Srila Prabhupada: I read something.

Next Day Bhavananda states: 9:57 “Prabhupāda was complaining of mental distress this morning”⁴

When asked about it he responded:

10:20 Srila Prabhupada: “That same thing - that someone (my disciples) think I was poisoned.”

Srila Prabhupada was distressed about how the appearance of his body was so severe it looked as if he had been poisoned! He knew it was disturbing it was for his disciples to see him suffering so much but there was nothing he could do to change it. We were all witnessing how his body was collapsing and most of us had never seen anything like this before. To make the best out of this terrible bad bargain, he kept teaching and reminded us to become serious about our KC because: “*This will also happen to all of you!*”

Proof 2: The Barely Audible Whisper Evidence

The Q#. content identifiers come from the audio samples on the video document produced by Truth Labs.

Cross references to the content found in **DECEPTION** provide the reader further analysis for the reader to consider. The analysis of this Truth Labs production confirms that it presents the same alleged whispers that would never be accepted in a court of law as evidence. It is just the same bad reasoning, repackaged into a polished format with a ribbon that includes a bouncing ball that leads even a hearing impaired individual to hear what the producers of this poison fraud want you to hear in these audio shadows.

Proof 1: The Audible Conversation With HDG

The word ‘poison’ was used in legitimate conversations around Srila Prabhupada’s bedside. These conversations referenced three specific areas: Ayurvedic medicines, Srila Prabhupada’s failing organs of filtration, and Srila Prabhupada’s changed appearance. Regarding Ayurvedic medicines, Srila Prabhupada made it very clear that he preferred Ayurvedic cures over modern allopathic treatments. Consequently, one of the first remedies his caregivers sought out was the Ayurvedic medicine makaradhavaja. There was a danger with this particular compound because it included mercury and if Srila Prabhupada’s body was too frail, it could have a poisonous effect. That was the first time the word poison was introduced into the discussion regarding his health.

As his condition grew worse, the discussion turned to how Srila Prabhupada’s longstanding diabetes had affected the kidneys’ usual work of removing waste products and extra fluid from the body. At that time, the conversation included references to how his own blood was acting as a poisoning agent.

The third way the word poison entered into the dialogue occurred when those accustomed to thinking of His Divine Grace as a robust octogenarian came to visit with him during the second half of 1977. The first thing to notice here is that the intent of the words changes radically depending on how it is punctuated. Was Srila Prabhupada making a statement or asking a question?

"Someone says that poison has been given? (It) may be true?"

It may be true that Srila Prabhupada was simply confirming how the makaradhavaja or his kidneys were poisoning him. That is the more likely inference instead of the highly contrived theory that his most intimated disciples were literally poisoning him!

- 6:58 Kaviraja:** Kisko? / To whom?
1:52 7:00 Srila Prabhupada: Mujhko. / To me.
1:54 7:04: Kaviraja: Kaun bolta hai? / Who Is Saying?
7:05: Srila Prabhupada: Ye saab friends / All these friends...
 Srila Prabhupada had heard all the discussions about how the makaradhavaja might have acted like a poison and how his organs were failing to purify his blood which would the act as a poison from within. He also had a regular flow of disciples visit for darshan who had not seen him for a long time. It is very reasonable to conjecture that when they first saw how frail he was they would be shocked and comment: "He looks like he has been poisoned!" Srila Prabhupada heard all these discussions so when he was asked who said he was poisoned he appropriately answered: "All these friends..."
2:00 7:09 BCS: Ke boleche Srila Prabhupada? / Who said, Srila Prabhupada?
7:16 Srila Prabhupada: Ke boleche / They all Say. (Someone has Said)
7:18 TKG: Krishna das?
2:20 7:30 Kaviraja: Aapko kaun poison dega? Kiselya dega / Who will give you poison? For what, why?
2:26: 7:35 Tamāla Kṛṣṇa: Who said that, Śrīla Prabhupāda?
2:45 7:48 Prabhupāda: I do not know, but it is said.

He could not specifically report who had talked about poison because his mobility was severely restricted and spent much of his time laying down. But we know Srila Prabhupada had excellent hearing and was quite aware of the numerous discussions that were going on about what was causing his loss of health, and the

2:58 25:15 Kaviraja: Yeh Maharaja, yeh kotha aap kaise bola aaj ki koi bola hi ki poison diya hai? Ye aapko kuuch abhaas hua hai, kya? / How did you say today that you have been poisoned? Did you get some indication or feeling about this?

The poison conspirators allege that nobody took what Srila Prabhupada said seriously when he used the word poison. But here the kaviraja is specifically requesting Srila Prabhupada to more clearly explain his poison comments made 18:41 minutes earlier. Srila Prabhupada responds very clearly.

3:10 25:26 Srila Prabhupada: Nahin. Eyse koi bola jo denese ye hota hai.. / **NO.** Someone said that, if you give then this things happens...

3:18 25:26...Shayed koi kithabme likkha hai /Maybe (my symptoms) it's written in some book?

When Srila Prabhupada was specifically asked if he had some feelings/suspicions that he had been intentionally poisoned he responded with a firm unequivocal **NO!** This is clear and unambiguous. The inability of the P-Con-Authors to accept this response is another switchback on their part. Remember they are the ones who said to *Brush off the words of the spiritual master was a great insult.* -KGBG 420-

3:25 25:24 Kaviraja That happens from some foods. Raw mercury makes it happen. And there are other things which can make it happen. I mean, who would do that to you? My understanding is that anyone who thinks about doing this to a saint, is a demon (rakshasa). -KGBG 122, 132, 287,779

The Kaviraja agrees that consuming some foods or raw mercury could be the cause of Srila Prabhupada's current condition. He elaborates that there are also other things that could have caused his health to decline. The Kaviraja had a lot of time to observe TKG's behavior at least for several weeks and he would not have made such a spontaneous comment in the presence of TKG if he ever observed him slipping in and out of the room at odd times to bring Srila Prabhupada glasses of milk that he never requested! We know from Abhirama's testimony that his care givers were regularly monitoring not just everything that came out of his body, but especially whatever Srila Prabhupada consumed! The Kaviraja completes his thought by concluding that the only type of entity that might be so demonic to want to hurt Srila Prabhupada would be a rakshasa, nor a Vaishnava what to speak of a disciple!

DECEPTION Section 7.2.6.1 HDG Note 5: Straight-forward English p. 215

The discussion about poisoning ended the day before with the Kaviraja pointing out that Srila Prabhupada's frail symptoms could be the results of bad medications, raw mercury or certain foods which would act like a poison.

We know Tamal Krishna Goswami was very attentive to minor details so he wanted to be sure about what Srila Prabhupada was trying to say previously when he mentioned poison. This is further proof that the devotees were vigilant about following up on the poison comments. Therefore, he inquired:

3:45 15:38 TKG: Srila Prabhupada, you said before that you... that it is said that you were poisoned?

Srila Prabhupada response was again firm and unequivocal...

4:01 15:51 Srila Prabhupada: **NO!** These kind of symptoms are seen when a man is poisoned. He said like that,

4:19 16:05 Srila Prabhupada: ...not that I am poisoned!

NOTE: The GBC got it right in 2001!

"Srila Prabhupada gives an unequivocally straightforward answer to a straight-forward question, "**No...not that I am poisoned.**" No amount of word jugglery now or in the future can take away the clear and simple fact that Prabhupada himself denied that he was poisoned." - NTIAP 48

Srila Prabhupada is indicating that the symptoms he was manifesting were like those of someone who had been poisoned. He then specifically indicates that someone else made this observation:

"He (the person who noted that my body looks beat up like it was poisoned) said like that, **NOT that I am poisoned.**"

What Srila Prabhupada was expressing was that he was not poisoned by somebody, but that his body was so emaciated it could have been poisoned by the bad ayurvedic medicine or his collapsing liver. The words "**he said like that**", clearly confirms that he hear others using the world poison and he was NOT complaining about being maliciously poisoned!

4:25 16:14 TKG: Did anyone tell you that (how your symptoms are same as those when a man is poisoned), or



you just know it from before?

Here TKG is still pushing for further clarification. He wanted to know where Srila Prabhupada got the impression that the symptoms he was manifesting could easily lead someone to incorrectly think he has been maliciously poisoned. This understanding is completely consistent with all the conversations he heard as his disciples were doing all they could to help him restore his health. The clause "know it from before" could not be a reference to fatal poisoned that had occurred before. It was to distinguish between general knowledge Srila Prabhupada had accrued prior to his rapid decline in his health.

4:30 16:21 Srila Prabhupada: I read something. -KGBG 122

Srila Prabhupada answers TKG's directly and explains how he had read something about the way the body is affected when it is subjected to poison. How could he possibly read about the process of someone poisoning him? It is much more logical to understand that he learned about the symptoms of poisoning somewhere along his professional career as a pharmacist. As a transcendentalist Srila Prabhupada was now observing how old age was affecting him the way poisoning that might occur from raw mercury, bad meds or inappropriate foods.

16:22 TKG: Ah, I see.

4:45 16:36 TKG: That's why actually we cannot allow anyone to cook for you.

16:46 Srila Prabhupada: That's good.

5:10 17:00 TKG: Jayapataka Maharaja was telling that one acharya, ...sankaracharya, of the Sankaracharya line, this is a while ago - he was poisoned to death. Since that time, none of the acharyas or the gurus of the Sankaracharya line will ever take any food cooked except by their own men.

TKG informs Srila Prabhupada how Jayapataka had shared the legend about the way one of Sankaracharya's disciples was apparently poisoned and how that led to not allowing any outside persons cook for the leaders in their sampradaya. If TKG was in the process of criminally poisoning Srila Prabhupada, the last thing he would do is to draw attention to, and discuss how someone plotted to poison a leader in the Sankaracharya line! The fact that TKG mentions this so casually is a tacit confirmation that he has absolutely nothing to hide.

17:34 Srila Prabhupada: My Guru Maharaja also.

Srila Prabhupada is pointing out how Bhaktisiddhanta Saraswati would also only allow his own immediate trusted disciples to cook for him.

6:05 17:55 TKG: Oh. You, of so course, have been merciful that sometimes you would take prasada cooked by so many different people.

TKG now praises Srila Prabhupada for being so kind he gave several of his disciples the opportunity to cook for him. We know that in many cases his cooks may have been new and not very expert in the culinary arts. Yet despite their shortcomings, Srila Prabhupada was merciful and did not adopt the more cautious and restrictive policies that had been in place in Sankaracharya's lineage for a long time.

18:04 Srila Prabhupada: That should be stopped

Srila Prabhupada decided that it was now time to restrict who could cook for him because his illness required someone who could be trusted to prepare healthy meals that would be easy for him to digest. This implies that Srila Prabhupada wanted to continue living so he could continue his service. If he had resigned himself to die, like the martyr scenario the P-Con-Authors contend, he would not have agreed to take further health precautions.

Q3a - Nothing listed!

This appears to be another typical example of the sloppy P-Con incompetence found frequently in their research!

6:24 -7:58 This is a conversation about the Mayapura Jagannatha Temple. Srila Prabhupada wanted to know who owns it and how big it is. This has absolutely NOTHING TO DO WITH allegations about poison! Allegedly there are incriminating whispers at the 15:37 time mark:

"Prabhupada Keeps Asking.. He's NOT going to stop until he finds out.. indistinct."

What are the poison advocates trying to tell us here? Srila Prabhupada was not going to stop until he finds out about what? What ever their answer is can only be speculative at best... but most likely it was a straight forward inquiry about the small Jagannatha Mandir in the nearby village. 10:05 BCS: Srila Prabhupada?

10:06 Srila Prabhupada: Hmm?

10:07 BCS: Ota ki byapaar hoyechelo? / mental distress? (What is that problem? Mental distress?)

10:14 Srila Prabhupada: Hm m m m m. Hm m m m m.

7:59 10:18 Kaviraja: Boliye, boliye / Say, say

10:20 Srila Prabhupada: Vahi bat jo koi hamko poison kya. / That same thing - that someone has poisoned me.

Earlier in the day TKG directly asked Srila Prabhupada "you said before that you... that it is said that you were poisoned?" and Srila Prabhupada clearly confirmed, NOT THAT I AM POISONED. Yet we see here that his disciples continued to inquire from him about this. It appears that because they had raised the issue again Srila Prabhupada realized that they had completely misunderstood what he had talked about earlier. Srila Prabhupada was distressed about how the appearance of his body was so sever it looked as if he had been poisoned! He knew it was disturbing it was for his disciples to see him suffering so much but there was nothing he could do to change it. We were all witnessing how his body was collapsing and most of us had never seen anything like this before. To make the best out of this terrible bad bargain, he kept teaching and reminded us to become serious about our KC because: "This will also happen to all of you!"

His words and mood suggest that he felt a strong obligation to set the record straight. He did not want anyone to make the egregious mistake of thinking he that he was accusing one of his disciples of being up to no good. The irony is that because the emotionally wounded are incapable of understanding his clear instructions, they have spent the 20 years doing exactly what he was attempting to prevent.

10:24 BCS: O aacha, uno soch na ki koi / Oh, okay, he thinks that someone...

Here BCS begins to repeat what Srila Prabhupada said, which would further reinforce the misunderstanding that Srila Prabhupada was accusing someone of maliciously poisoning him. The Kaviraja was more astute to what Srila Prabhupada was expressing so he jumped in to get BCS's attention to explain that Srila Prabhupada was NOT accusing anyone of attempting to murder him but that it is possible some Rakshasa may be causing mischief.

8:32 10:28 Kaviraja: (speaking over Bhakti Charu Swami):

Dekhiye bat yehi hai ki kisi rakshas ne diya ho...

"See the thing is that some raksasha has given..." (his sentence was cut off)

It is hard to realize by reading the transcript alone that at this moment several people were all talking at once.

BCS did not realize that the Kaviraja was trying to get his attention so he kept speaking.)

10:33 BCS: Someone gave him poison here?

BCS is guessing how the Kaviraja might have completed his sentence.

10:33 Kaviraja: Caru Swami⁵...The Kaviraj is still trying to get BCS attention.

10:34 BCS: Yes. BCS finally realizes that the Kaviraja was calling his name so he stopped talking over him and just acknowledged him with "Yes?")

10:35 Kaviraja: kisi rakshas ne diya ho. Yeh to ho sakta hai. Impossible nehi hain. Woh Sankaracharya the; unhe kisi ne poison diya. Cheh mahina tak woh bari taklif paye. Kanch to hota hai na ? botal ke kanch, yeh pees ke khanemein khila diya. To usko kya nitaja hua; bara mahina baad mai, leprosy ho gaya sab sharir ki undar. To karamto apna bhugte hai. At this point in the conversation, the Kaviraja is anxious to jump in and summarize several of these points that Srila Prabhupada had said. He is also noticeably nervous that maybe someone might wonder if the medicines he gave could be the poisons Srila Prabhupada was referring to. So, he vigilantly reassures everyone "... the medicine I have given, if any (poisonous) effect occurs; it cannot stay. I give a guarantee, that even **if there are effects, they will not stay...**"

There is nothing here to suggest that Srila Prabhupada was secretly telling him that he had been poisoned by any of his beloved disciples. He did comment that some Raksasha could have given some poison and that would NOT be impossible, but the Kaviraja would never be so audacious to refer to one of Srila Prabhupada's disciples as a "raksasha."

If Srila Prabhupada had confidentially hinted to the Kaviraja anything about someone poisoning him, the way the poison alлегers claim he did, why was he so anxious to clear himself of any possible unintentional wrong doing? If there was even a hint of someone acting suspiciously the Kaviraja would have revealed that information to protect himself from mal practice.

9:18 11:14 TKG: Prabhupada was thinking that someone had poisoned him?

Now TKG is reacting to what BCS was also trying to better understand. Prior to the Kaviraja providing this longer explanation of what he discussed with Srila Prabhupada they were both confused. They were curious to know if Srila Prabhupada was expressing concerns about somebody poisoning him.

11:15 BCS:_(not Adhridharan): Yes.

BCS was answering TKG that: "Yes... (Based on the prior portions of this dialogue, BCS was confirming that Srila Prabhupada was still concerned that his disciples had misunderstood him and they might think he was accusing someone of poisoning him.)"

11:16 TKG: That was the mental distress?

11:17 BCS: Yes.

Srila Prabhupada had already clarified: "**Not that I am poisoned**" However, he had observed on many occasions how his western disciples would often misunderstand his instructions, directions, or intentions. It appears that His Divine Grace was now concerned that a big misunderstanding could brew up if he did not take the time to straighten out the mix-up over his use of the word poison. In retrospect we can appreciate the mystical way Srila Prabhupada could foresee exactly what occurred. Despite how many times he asserted that he was NOT talking about a plot to poison him, some of his rationally challenged disciples cannot understand the straight forward words of His Divine Grace without extrapolating unintended meaning out of them!

9:22 11:18 Kaviraja: Yeh bolte hai to isme kuch na kuch satya he. Isme koi sandeha nahin. / **This is what (he) says, then there must be some truth in it. In this there is no doubt.**

This is the first thing the Kaviraja says after his long monologue commented above. When he got done translating the many things, he had just mentioned he declares: "**This is what he says.**" He revealed that in his opinion, Srila Prabhupada had been experiencing mental distress because of all the various conversations her heard where the word poison was used by his caregivers and visiting guests.

9:28 11:27 BCS: He said that when Srila Prabhupada was saying that, there must be some truth behind it. - KGBG 4, 24, 124, 145, 146, 288, 353, 447, 568, 570, 787

Once again, the advocates of this terrible ruse add their spin to the conversation to make their arguments sound more convincing. BCS begins his sentence with "**He said**" and then he explains to TKG what the Kaviraja said. There is no indication here about how BCS felt about it, he was just repeating what he had heard.

11:28 TKG: Tsheeesssh. (Everyone begins speaking together)

What to say...(or) something in milk. To eat, (he) will put a medicine in pan, by the morning (your) whole life can be forgotten.

Here the Kaviraja is postulating how a raksasha might go about killing a person. He confirms that if a raksasha wanted to poison someone then that individual would be dead by the next morning. ISKCON-Bashers speculate that the Kaviraja is referring to TKG when he uses the word Raksasha but that makes no sense because the definition of a raksasha is one who is anti-god.

9:53 11:50 TKG: Srila Prabhupada, Shastriji says that there must be some truth to it if you say that. So who is it that has poisoned? (pause of 13 seconds of dead silence).

DECEPTION Section 6.3.2 The 13 Second Misdirection p. 191

Srila Prabhupada never answers this question but there is NOTHING alarming about this. At this point in time there was often very long intervals of well over a minute before His Divine Grace had the strength to vocalize and answer. This time gap is fully mitigated in *Using Silence to Deceive*.

DECEPTION Section 6.3.3 Using Silence to Deceive p. 192

Now the attempt is made to misrepresent what TKG said the same way they did with BCS. He begins his sentence with "Sastriji Says" and then he virtually repeats verbatim what the Kaviraja had just spoken: "that there must be some truth to it if you (Srila Prabhupada) say that." At this point TKG goes along with what the Kaviraja said out of respect for his opinion. Perhaps an explanation for why Srila Prabhupada got so ill is because of the mischief of a rakshasa.

"Even Tamal Krishna Goswami himself at the time said that there must be some truth to it. -KGBG 164

Tamal is just echoing the words of the Kaviraja who introduced the idea that perhaps an (invisible) raksasha could be involved in tormenting Srila Prabhupada. He has not had time to come to his own personal conclusion and he certainly is not confessing that he **IS THAT RAKSASHA**. There was a lot of speculating going on. This is where a Hollywood script writer would point out a serious continuity problem with the script written by those who wrote the poisons conspiracy script. What is more relevant however, is to note that both BCS and TKG were simply repeating what the Kaviraja said. The wounded use this exchange to embellish the conversation with their agenda to arrive at a forced conclusion that this is proof that Srila Prabhupada was poisoned.

"At the time of these discussions, the final conclusion by Tamal, Bhakticharu, Shastriji, and others that there must be some truth to Srila Prabhupada's being poisoned,"-KGBG 349

The misdirection forced into the above exchange is evident by the fact that the record repeatedly indicates that both BCS and Tamal Krishna have never given any credence to the poison conspiracy. A clear assessment of what was going on is that Srila Prabhupada was right there. He could hear everything that was being said and the mood of hypnotic pandering was having its effect. Both BCS and TKG were anxious to concur with whatever the Kaviraja and Srila Prabhupada discussed just to get along. However, it has never been established just what it was they were concurring with. Were they just acknowledging any of the various ways Srila Prabhupada's health could have been compromised when they agreed: "...there must be some truth in it?"

If these senior devotees had conspired to poison Srila Prabhupada they would do all they can to discredit everything the Kaviraja said that could be understood suggesting any type of murderous act! If Tamal Krishna Goswami or BCS were poisoning Srila Prabhupada, why would they confess that? Those guilty of acting improperly avoid anything that might shed the light on their crime, to not do so would be an example of *Brilliant Stupidity!*

At that moment everyone was struggling with the fact that His Divine Grace was hovering on the edge of departure and it is to be expected that the emotional tension had brought the mood to a state of intense feelings of helplessness. Instead of respecting the emotional angst everyone was experiencing, and empathizing with those who were there during these historic last days, the heartless promote the ugly poison rumor as an ideal opportunity to further their *vengeful agenda* far and wide.

It appears that even the Kaviraja became a bit star-struck. He was simply trying to comfort Srila Prabhupada by letting him know they were still listening to him. Whatever Srila Prabhupada was trying to say must have had some validity, but it had to be within the context that he had already established: "No, NOT that I am poisoned." This was challenged by the fact that between Srila Prabhupadas' barely audible utterances, the assembled devotees would frantically try to figure out what it was he wanted them to do.

The P-Con-Authors completely misrepresent what was going on by suggesting that those who had lived for every word Srila Prabhupada said *now did not care about anything he said*. They portray these senior devotees as if

ISKCON Poison Bashers know that the confusion surrounding the various medicines Srila Prabhupada was given is their Achilles heel so they commit seven pages in an obvious attempt to beat it out of the picture.

Notice that all of the clauses championed in this portion of the Truth Teams “Forensic Report” are included in this list collected over twenty years ago. The irony here is that the newly formed “Justice for Srila Prabhupada” had the presence of mind to toss Nico Kuyt under the bus because his reputation is so disgraceful he became a liability in their effort to bring credibility to their maligned poison allegations. Yet even the deranged Nico had enough presence of mind to realize how difficult it would be to use the majority of these hidden audio sound bites as evidence for a plot to commit murder by poison. Yet here we discover that seven of these previously rejected whispers have been resurrected in a desperate attempt to convince the public that TKG plotted to poison Srila Prabhupada. What is not explained by these new directors of the poison conspiracy, is how ANY of the phrases cited here, with the exception of the first one, could be construed as proof that there was a plot to poison Srila Prabhupada!

Usage of the “Poison” Word:

We are told seven different audio forensic engineers confirmed that the content of the so-called “whispers” offer proof that Srila Prabhupada was poisoned. However, upon careful examination of what these individuals actually reported, we discover the ONLY thing they agree on is the presence of the single word “poison” and that alone does not prove murder!

Srila Prabhupada used words like “nectar” and “poison” quite extensively when he spoke. To appreciate how often he used them we counted them in his books, correspondences and audio transcripts. The word nectar showed up 1902 times and the word poison 776 times. (77600/1902 = 40.79) 41%. This contributes to the previous explanations for the presence of the word poison in the last few taped conversations. It is completely inappropriate to claim that the presence of he only word all the forensic engineers agreed on is NOT proof of murder! Therefore, the available audio does not unequivocally indicate that Srila Prabhupada was poisoned nor does it suggest that he complained about being poisoned. To assert otherwise reflects a litany of contrived speculations originating from a severe case of confirmation bias.

By November of 1977, Srila Prabhupada’s body was finished. Each of his attending disciples were struggling to comply with his emphatic request to not take him to a hospital or seek treatment from a “*blood drawing & injection giving*” allopathic doctor. They had to weigh that against their own ideas and hopes about what might facilitate his recovery. We learn from TKG’s diary one of the things he considered during this difficult time.

TKG: “... The horoscope is written in such a way that **if you survive these catastrophes**, then it mentions that... He said that **you would live for another five or six years.**” -Room Conversation Oct. 21, 1977

Every Vaishnava should take a moment to understand the unbearably awkward dilemma that those responsible for nursing His Divine Grace found themselves in. Ask yourself how you would have balanced the difficulty between Srila Prabhupada’s request to not involve any modern medicine in his recovery, and his request to go on a parikrama that many felt he could not possibly survive? How these two extremes would get resolved would have an impact on how long His Divine Grace would be permitted to keep instructing us directly. These were very sacred intimate moments complicated by a lot of diverging opinions. Everyone had an opinion and the stakes were very high. What would you have done?
